Text entries with name and WPRA card number and position number to 662-418-3963. You will receive a text acknowledging entry.

Filling open positions after entries have closed. If the top 12 eligible persons do not enter, positions will be filled by dropping down the list of the DC standings **OF THOSE THAT ENTERED** while entries were open. You will be notified and asked to accept or decline.
