Ground Rules: Contestant Information:

All Timed event cattle must be pre-conditioned at least two (2) hours prior to the rodeo start time. Timed event cattle will be moved to the timed event end of the arena at the first request of members that are to pre-condition cattle.

Every attempt must be made by both the tie down ropers and the stock contractor to pre-condition the calves early and out sight of the audience.

Arena will be locked and no contestants will be allowed to ride in the arena after 12:00pm on each rodeo day.

Walk Up Replacements: Contestants who have originally entered and were eligible at time of entry may in person check with the Williams Lake Rodeo secretary no later than 1 hour prior to the performance to confirm their availability and desire to be an alternate. If selected, by a random draw of all walk ups available, an alternate will assume the competition position of the contestant that they are replacing. In rough stock they will draw stock from a pool of animals consisting of all turned out stock for that performance and All re ride stock for that performance. If stock has already been drawn in the timed events contestant will receive the stock that has been drawn for that contestant.

* If a contestant notifies a turn-out, DR or visible release and is replaced by an alternate, the alternate contestant will be responsible for the entry fees. If the contestant that notified the turnout or visible release is not replaced by an alternate, they will be responsible for the entry fee. If a contestant properly doctor releases they will not be responsible for entry fees.
