#### 2022 Tucson Rodeo Ground Rules- WPRA

1. Performance/Slack Information:

Perf #1- February 19, 2022.... 2:00pm  
Perf #2- February 20, 2022.... 2:00pm  
Perf #3- February 24, 2022.... 2:00pm  
Perf #4- February 25, 2022.... 2:00pm  
Perf #5- February 26, 2022.... 2:00pm  
Perf #6- February 27, 2022.... 2:00pm  
Slack #1- February 21, 2022.... 8:00am  
Slack #2- February 22, 2022.... 8:00am

2. All contestants will be required to sign a contestant release form before they will be allowed to compete.

3. All contestants will be required to enter the competition arena through the alley gate at a run.

4. Fenced warm-up area and alley adjacent to timed event chutes along with header and heeler boxes shall be considered part of the arena and be subject to member dress code.

5. One hundred-five (105) entries, 56 will be selected from the 2021 qualification standings; 14 will be selected from 2022 pro rodeo standings; 24 will be selected from 2021 WPRA/PRCA Turquoise Circuit standings; 6 will be selected from the 2021 WPRA/PRCA Turquoise Circuit standings; 5 will be selected from 2021 WPRA Tour standings.

6. Format will be one (1) round with finals; top twelve (12). Will run twelve (12) contestants in each performance.

7. Slack. First section of slack will be Monday, February 21, 2022 at 8:00 AM. Barrels will be run first with twenty-three (23) runs. Second section of slack will be Tuesday, February 22, 2022 at 8:00AM. Barrels will be run first with twenty-two (22) runs.

8. Ground rules and arena access rules will be posted in the PRCA Secretary's office.

9. In case of any malfunction of the electric timer for any reason, field flagger times will be used. No reruns will be given for any reason.

10. Barrels may not be placed in the arena for practice at anytime. Access to arena for contestants will be set by Arena Director. No warming up of horses in the arena during any paid performance.

11. Contestants must wear back numbers when competing during paid performances,

12. Contestants who park on Third Avenue (East of Rodeo Grounds) or on private property along Third Avenue may be subject to ticketing and/or towing at the vehicle owners expense. The Tucson Police Department will site anyone who leaves refusing to clean up (including manure, hay trash, etc.) along Third Avenue on either public or private property.

13. The Tucson Rodeo Committee will tow ANY vehicle parked in an unauthorized area on the Tucson Rodeo Grounds.
