General Release of Liability: I acknowledge that horseback riding is a dangerous sport which carries inherent risks of injury and damage to me, my horse, and property. I knowingly assume all risks, whether known or unknown, of horseback riding. I hereby release the Sonoma County Fairgrounds and GSGRA/BAC, or any of its agents (hereinafter, the "Released Parties") from all liability for any act of negligence or want of ordinary care on the part of the Released Parties and/or any of its agents, in consideration of my participation in events organized or sponsored by the Released Parties or use of the real and/or personal property. I waive, release and discharge the Released Parties, their directors, officers, agents, and members, their representatives, heirs, executors and assigns from any and all claims of liability for injury or damage to myself, my animals, or my property arising out of my participation at events or of my use of the Sonoma County Fairgrounds real and/or personal property. This agreement is binding upon my executors, heirs and assigns I expressly waive any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affect his settlement with the debtor." I agree that I will indemnify and hold harmless the Released Parties, their officers, directors, members, and agents against all claims, demands, and causes of action, including court costs, and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld. The Released Parties, its agents or employees shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to person, horse or property. I acknowledge that I have read this Release of Liability and know and understand its contents. **Sonoma County Fairground's Release of Liability:** As a voluntary participant in Barrel Racing offered by the Sonoma County Fair Division, I hereby waive, release and discharge the County of Sonoma, and its respective officers, agents, employees, volunteers and representatives (hereinafter, the "Released Parties") from any and all liability for any loss, injury or damage to persons or property, including liability arising from any act of negligence or want of ordinary care on the part of Released Parties, arising out of or otherwise relating to my participation in this program. Disclosure of possible risks associated with this activity included, but are not limited to, handling of horses and horseback riding activities. I further agree that I will defend, indemnify and hold harmless the Released Parties from all claims, demands and causes of action, including court costs and attorney's fees, arising from any proceeding or lawsuit related to the subject of this release.
