Where: The 2023 California Divisional Circuit Finals will take place on Saturday, November 18, 2023 at 10:30 am.

Our finals will be held in conjunction with the 7<sup>th</sup> Annual National Fantasy Barrel Race & Rising Star Futurity Barrel Race.

Cut-off date for standings: September 30, 2023

Who: The California Divisional Finals will consist of the top 12 in the standings WHO HAVE ENTERED THE EVENT. All cardholders (even if below the 12th position) are encouraged to enter, as we often have to go further down into the standings to fill the 12 spots.

**We will be having an OPEN Permit Finals.**

**Meaning that ANY permit holder (2023 or 2024) may enter!**

**Entry Information: Entries will open on Monday, October 30, 2023 , and close on Friday, November 3,2023.**

**\*\*Entries will be taken on Fastener.**

The Divisional Finals, Permit Finals, and will all be one (1) run.

Entry fees: Divisional Finals: \$65 (\$55+\$10 office charge)

Permit Finals: \$60 (\$50+\$10 office charge)

Fees will be taken the weekend of the event, CASH ONLY.

You may carry your time from the Divisional Finals race to Saturday's Open race. Please make sure to select the "carry from WPRC race" option when entering the NFR Open (as well as any side-pots).

- Divisional Finals will have \$1,000 added and will pay 4 places.
- Permit Finals will have \$500 added, payout will depend on number of entries (will payout according to pay scale in the WPRA rule book)

Turn Out Deadline: Contestants may turn out until Wednesday, November 15, at 12:00pm. You can turn out by contacting Sheena Robbins at (559) 940-2638. Permit Race contestants who turn out prior to the deadline will not be responsible for their fees. Cardholders and Juniors ONLY:

If you turn out prior to the deadline AND a replacement is found, you will not be responsible for your entry fees. If a replacement is NOT found, you will be responsible for payment of entry fees.

Replacement procedure: Any open positions will be filled by contacting the NEXT highest ranked contestant in the 2023 standings WHO ENTERED THE DIVISIONAL FINALS.

*All Contestants:* Failure to turn out by the deadline (aka "Non-notified turnouts) will cause you to be responsible for entry fees, and you will also be assessed a \$50 NNTO fine, payable to the WPRA California Circuit.
